Thence South 51°22'03" West for a distance of 1048.87 feet to a point on the easterly right-of-way line of said Old US Highway 30;

Thence North 38°37'57" East along said right-of-way line 40.00 feet parallel and perpendicular from the centerline for a distance of 233.99 feet to the southeast corner of the lands described in that warranty deed instrument No. 98024430 and 98024431 as recorded in the official records of Bannock County, Idaho;

Thence along the southeasterly, easterly, and northwesterly boundary lines of said lands for the following five (5) calls:

- (1) Thence North 51°22'03" East for a distance of 200.00 feet;
- (2) Thence North 38°37'57" West for a distance of 180 feet to the beginning of a 20.00 foot radius tangent curve concave southeasterly;
- (3) Thence northwesterly along said curve to the left through a central angle of 90° for an arc distance of 31.42 feet to the point of tangency (Chord bears N 83°37'57" W 28.28feet
- (4) Thence South 51°22'03" West for a distance of 150 00 feet to the beginning of a 30.00 foot radius tangent curve concave southeasterly
- (5) Thence Southwesterly along said curve to the left through a central angle of 90° for an arc distance of 47.12 feet to the point of tangency (Chord bears S 06°22'03" W 42.43 feet) to a point on the easterly right-of-way line of Old US Highway 30;

Thence North 38°37'57" East along said right-of-way line, 40.00 feet parallel and perpendicular distant from the centerline of said highway for a distance of 388.01 feet; Thence North 51°22'03" East for a distance of 1111.06 feet to the True Point of Beginning. Contains 18.75 acres of land.

RESERVING unto the Grantor Thomas C. Katsilometes a right of roadway and utility easement over and across said tract sixty (60) feet in width, leading from Old U. S.
