Enclosed are the results of the lot evaluations (perc tests) that were conducted on the above-referenced property. The test results are acceptable provided each new lot is at least two (2) acres in size.

A plat of the subdivision must be prepared by a licensed surveyor showing the test locations, test data, a 10,000 sq. ft. sewage reserve area drawn around each test site, location of the proposed water supply wells, and the location of existing wells and sewage disposal systems located within 100 feet of the proposed boundaries.

For these test results to remain valid, a copy of this plat must be submitted to the Health Department within six (6) months of the above date.
